This activity would include setting standards for documenting, preserving, and making history information available to historians, researchers and others.





THE CHANGING WORLD OF LIBRARIES AND MUSEUMS

When we became involved with MLMA initially, it seemed like 'just another Masonic organization'. How much our perception of this has changed over the past year with Ed assuming the duties of Grand Librarian for the Grand Lodge of Maine. Having been exposed far more than we could have imagined to OPACs, shelf labeling, public access, security, meaningful use, etc. etc., the need for contemporary and meaningful sharing amongst colleagues in this very narrow field seems much more germane.

AN EVOLVING LANDSCAPE

It's now much clearer to us that those who care for a library/museum relating to the fraternity of Freemasonry have not only a job (with or without compensation) but a labor of love. However, the shrinking Masonic membership to support collections coupled with the easy availability of information online (albeit FAR less complete and – in many cases – accurate) makes many, including those who fund our institutions and ourselves, begin to question the relevance of what we've accumulated and why it should continue being funded.

MEETING THE CHALLENGES

If there's one thing that our deep exposure to the many facets of Library and Museum management has revealed during this past year, it's the need for a central repository for sharing: ideas, opportunities, motivations and, most especially, dreams and aspirations. In many other fields, professionals see themselves as 'colleague-competitors'. In this arena, however, we are all striving to 'do the right thing' and the success of one can be a success for all if we are ready to adapt and grow. It's the 'rising tide floats all boats' concept and using the many facets of social media, it can be done through MLMA!

WE WOULD ENCOURAGE...

Adam Kendall has given us just a brief taste of what can be done through his Facebook postings on the MLMA page – and we personally have found them delicious and enticing. If only many more members could begin using this or some other emerging technology to 'spread the word' about their institutions (and, simultaneously, MLMA), the mission and message of the relevance of Masonic Libraries and Museums could be far more widely felt. Even little things ("The Grand Lodge of Maine is pleased to announce that it's entire catalog is now available online....", for example) would show movement/progress and point to a need. Too old or too little time to use Facebook? Send it to us and we'll get it up there for you (but remember: "the times, they are a changin" and you need to stay up-to-date with the world – as bizarre as it sometimes is!).

Using the social media outlets of the MLMA, your organization's commercial offerings (books for sale, etc.) could be more widely publicized. A press release to us could then be used to send it out in the organization's name. Some institutions have some things for

sale while others have none: it'd be great if we gave our member organizations a discount on whatever we had available – and publicize that through the MLMA website and other MLMA media outlets.

If someone has some artistic capabilities, perhaps a graphic proclaiming MLMA membership would be helpful in such a promotion? The opportunities are endless and although at times it seems like we're simply tossing rocks into a vast ocean of information polluted with sewage, one never knows where those ripples will wind up.

Further, and on a grander scale, setting up a combined Masonic OPAC as well as an inter-library loan cooperative amongst our institutions could be of great value as well. Just some of the many late-night ideas that we've discussed here at the King Castle! <grin>

Yes, we all have FAR too much to do 'in house' than to think about 'propping up' yet another group but having seen what great connections can be made through this organization, I believe that this is one which is truly worthwhile supporting.

On that very note, a very special thanks to Brian Rountree who reached out to help a struggling neophyte totally overwhelmed by the chaos he found when becoming Grand Librarian. His caring and concern was and continues to be MOST appreciated.

PLEASE let us know what we can do for the Masonic Library & Museum Association moving forward! Oh, and if you do come to Maine to visit (and if you don't, you're really silly!) and you head up to Bar Harbor (doesn't everyone?), PLEASE let us know. APPENDIX 3 OVERSEAS MEMBER REPORTS

THE LIBRARY AND MUSEUM OF FREEMASONRY, LONDON REPORT TO MLMA 2013

This report is sent with our best wishes for a successful annual meeting.

Our exhibition this year *Encounters: Artists and Freemasonry* has drawn on our own collections and used loans from across Europe to explore individual artistic responses to freemasonry. William Hogarth or Alvin Langdon Coburn looked at freemasonry within their established fields of, respectively, satirical prints and photography. It has proved to be very attractive to the public.

A new exhibition opens in mid October 2013 (*Excellent Companions: Celebrating the Royal Arch*) to coincide with the special Convocation of Supreme Grand Chapter which is celebrating its 200th birthday- if you take its birth as the Union in 1813. Despite the dubious chronology of this, it is an excellent opportunity to put on a display about the origins of the Royal Arch and explore its symbolism. Many objects have not been seen on display for many years. We are also including documents relating to the Union in the display.

Cataloguing continues across the collections. We have had a grant from the publicly funded Arts Council this year which has enabled us to catalogue over 1500 commemorative masonic medals including about 500 American and Canadian examples. This is all available on the catalogue pages of the website.

In partnership with the Public Catalogue Foundation ("PCF"), details and pictures of the 150 oil paintings in the collection at Freemasons' Hall in Great Queen Street were made available in December 2012 as one of over 3,200 venues across the UK participating in a joint project between the PCF and the BBC to put online the United Kingdom's entire collection of oil paintings in public ownership ("Your Paintings"). The Freemasons' Hall contribution was managed by the Library and Museum who provided additional research into subjects and artists and obtained high quality digital images of all the paintings. It is one of many collections that are not in public ownership which have joined the project for the benefit of wider public awareness and research. Our long term project to digitise masonic newspapers finally launched early in 2013 as Masonic Periodicals Online which includes all the editions of the specialist masonic press published between the 1790s and the early 20th century, a total of 75,000 pages, scanned and searchable on line. The database is accessible via the Library and Museum website at http://www.masonicperiodicals.org.

We have completed the microfilming of membership registers after 1886 and we are now finalizing how to make historic (pre 1920s) membership information available on a searchable database.

The UK government is funding an element of the commemoration of the First World War including (with the Heritage Lottery Fund) the First World War Centenary Partnership led by the Imperial War Museum (IWM), a network of over 1,000 local, regional, national and international cultural and educational organisations from 27 countries around the world. We have signed up to the Partnership in order to benefit from the publicity opportunities it offers and to help develop further links with other collections.

In planning exhibitions, displays and events relating to this Centenary, we have taken into account that Freemasons' Hall itself is a war memorial and that the centenary of the launch of the Masonic Million Memorial Fund is not until 2019 ie the end of the period. Next September we will open an exhibition entitled *The Turbulent Years: English Freemasonry and the First World War*. This is intended to be a broadly focussed exhibition looking at the years c1900-1930. We are working with a publisher on a book to be called *English Freemasonry and the First World War* to mark the launch of the exhibition.

AMMLA

Association of Masonic Museums, Libraries and Archives

Vienna July 4 - 7, 2013 (2014: Poznan, Poland)

This year's conference was held at Schloss Rosenau near Zwettl (a town northwest of Vienna, not far from the Czech border), the home of Graf Leopold Christoph von Schallenberg (1720-1797), who had 7 rooms of the palace furnished as lodge rooms. It is now the home of the Austrian Masonic Museum.

The theme was European anti-Masonry, for which our host, Dr. Peter Back-Vega, mounted an exhibit, to which the Museum of Our National Heritage and the Masonic Library and Museum of Pennsylvania contributed images. A few AMMLA members last year said they wanted to hear about anti-Masonry in the United States (so Glenys gave a short talk, "Anti Masonry in the United States - A Brief Overview », which relied greatly on the excellent work of our own Jeff Croteau. It seems that all most Europeans know is something about the Morgan Affair. The paper emphasized that there is much more than the Affair, which was put in historical context, and went on to talk a little about the Anti-Masonic Party, and anti-Masonry today – especially about the Southern Baptist convention and Dr. Gary Leazer.

In addition to the papers on anti-Masonry, there were presentations on the new Masonic Museum in Prague, and the German Masonic Museum in Bayreuth (where AMMLA met in 2009), which has a renovated exhibition hall and a new exhibition.

The meeting opened with a memorial tribute to Michel Brodsky founding member of AMMLA, who died earlier this year (adapted from President François Rognon's Homage): "Michel Brodsky was one of the first to see the need for exchanges between the various sources of studies on the history of freemasonry; he organized the first European conferences of research in Masonic history with the Université Libre de Bruxelles. Very early on, Brodsky saw the interest in the creation of an association of the

European Masonic Museums. He was the first brother from the Euopean Continent to become Worshipful Master of *the* research lodge, England's Ars Quatuor Coronati. Diane Clements, Director of the Library and Museum of UGLE, said of him, 'Michel's name and work will be well known to many of members of AMMLA. That is a tribute to his cosmopolitan approach. He has always keen to build links between collections (and the individuals that were involved with them) and set an example with his enthusiasm for Masonic research. We must preserve this enthusiasm..."

The Masonic Museum of Corfu, Greece, represented by Curator Spyros Andriotis, was welcomed as a member of AMMLA.
